# **Approval of Minutes:**

Letters from Office of Commonwealth Libraries granting certification extensions to new librarians at Boyertown Community Library and Boone Area Library.

## **Administrator's Report:**

Sticha discussed website redesign and then moved on to current status of Federal and State budgets. Both Senate and House have included funding in their plans. State has approved level funding while decreasing funding for the State Library. The appropriations bill has not been passed and monies have not been released. District Center Agreement includes plans for a certified youth services position. Hoopla

will be continued. Training will also be continued.

It was also agreed not to spend additional money on Zinio, the digital magazine platform.

The IVY Group report was reviewed and un update of where we are was given with a summary of the different categories. We must work collaboratively to stop duplication and also focus on interlibrary loans.

The State Library Project, Turning Outward was introduced (For more information see attached sheet.) as a competitive grant program.

It addresses the issue of the library's role in terms of community goals.

Sticha then went on to discuss the website, showing samples of web pages.

#### **Finance Committee:**

Edwards reported that the committee is continuing to make progress on the funding formula revision.

#### **Advocacy Committee:**

Schwambach announced that the third advocacy workshop, **Advocacy**, **Your 10 Step Plan**, has been scheduled for September 20, 2017 from 6:00 to 8:30 p.m. at System Headquarters.

#### **Unfinished Business:**

None

#### **New Business:**

Social Media Policy has been written and is currently at the County Solicitor's Office for review. Questions raised include determining who is in charge and who monitors the account. There is a need to limit staff in terms of freedom of expression. In the future, there will be a guide for county libraries' use of social media.

Another issue to be addressed in terms of the website is the use of release forms for photographs. The solicitors will handle this.

Policies will need to be posted on the website. For now, we are keeping this situation "low key."

Motion was made to schedule next meeting, the third Wednesday in November. Schuchman motion, Kimball, second. Motion passed.

## **District Center Update:**

No Board meeting was held. The city has approved the contract for heating and ventilation and the Board is seeking \$30,000 in additional contributions for the project. Comic Con was successful with several hundred people attending.

#### **Announcements:**

Audits are due October 1. Boyertown has opened its new facility as of August 14. Book Bonanza has cleared its space moving some books to storage and discarding others.

Muhlenberg invited everyone to visit Riverfest and the library's fundraising booth.
