Abby Brunner, Library Director, reported May's circulation of 2,657 items decreased from April's of 3,321 items. May's computer usage of 220 sessions decreased from April's of 347 sessions. In May, 10 programs were held with 212 in attendance as compared to April's 18 programs with 373 attendance.

Received request from Book Bonanza for volunteers on June 11-14, 2019 to sell and sort books.

Director's Forum, May 24,2019 focused on library passes. There will be a test period for ordering materials from Overdrive.

Code of Conduct was reviewed and updates were discussed. A motion to approve new version was made by Kevin Kurtz and seconded by Abby Wertz. Board cast a voice vote of approval.

Director's Meeting, May 28, 2019, discussed partnership with Reading Public Museum and a summer reading program for adults featuring a book by Sue Klebold, "A Mother's Recogning".
